



California Sun Dried Tomatoes

DESCRIPTION

California roma-type tomatoes are prepared from clean, wholesome, red, mature fruit. The tomatoes are washed, machine cut and carefully laid on wood drying trays, treated with sulfur dioxide, then dried in the California sun. After sun drying is completed, they are processed according to style of cut. The drying process consists of sunlight only.

Packed in a non-sealed food grade poly bag inside a corrugated box.

Store in a cool, dry atmosphere not to exceed 45° F. Shelf life may be extended if stored below 0° F. All products must be stored under proper warehousing conditions and temperatures to preserve the product and prevent discoloration.

Traina California sun dried tomatoes do not contain any allergens as defined by the FDA. These products do contain sulfur dioxide which is used as a processing aid and as a preservative. Some people may be sensitive to sulfites.
